The Wife in this case was granted innocent spouse status by the IRS and by NYS. The Husband subsequently transferred by Quitclaim deed his title and interest in the real property to the Wife after the New York State tax warrant was issued and entered in the office of the county clerk. The Federal was issued and entered after the Husband quitclaimed his interest in the real property but before the deed unto the Wife was recorded. The background is that the Husband was prosecuted for embezzling from his employer. He was prosecuted criminally and was incarcerated. The Wife has been occupying and maintaining the real property as her home. It was formerly the marital residence, built on land the Wife owned prior to the marriage.

The US residents would contract with the US subsidiary for the services. The US subsidiary would have a US bank account and take payment from the US customers. The European company software developers would interact with the US customers. Most of the funds earned would be transferred to the European company. Related questions are the best form for the US subsidiary, best state for tax purposes to establish US subsidiary, tax rate for US subsidiary on its US taxes, whether a US tax liability would be incurred by the European company, whether the location of the servers (in or out of US) has an impact on the tax liability.
